- 3. Buyer signs and returns FCO along with NCNDA
- 4. Seller issues Contract
- 5. Buyer reviews Contracts for changes if any required & signs Contract
- 6. Buyer's bank issue's pre-advice letter to *Enoxpetrol* stating upon receipt of FULL POP, on behalf of Buyer our bank will issue one of the described payment instruments (Irrevocable revolving, transferable Letter of Credit/block funds, MT103/23, MT760, BCL, or MT799) for payment under the given contract number supplied in Buyer's contract issued by Seller.
- 7. Partial POP is sent via Sellers Bank to Buyer Bank by SWIFT or email to includes (SGS Report, Tank Receipt, Dip Test, and Attestation Letter)
- 8. Buyer sends POF via Buyer Bank to Sellers Bank by SWIFT or e-mail

- 9. Sellers sends Non-Operative 2% PB to activate Buyers POF to MT103 or MT760 and releases Full POP to Buyer
- 10. Both parties exchange hard copies of contract via Carrier and lodge contracts with their banks
- a. A copy of the seller's license to export
- b. A copy of the sellers Approval to export
- c. A copy of the transfer contract to transport to Buyers port of destination
- d. A copy of the Pro-forma Invoice
